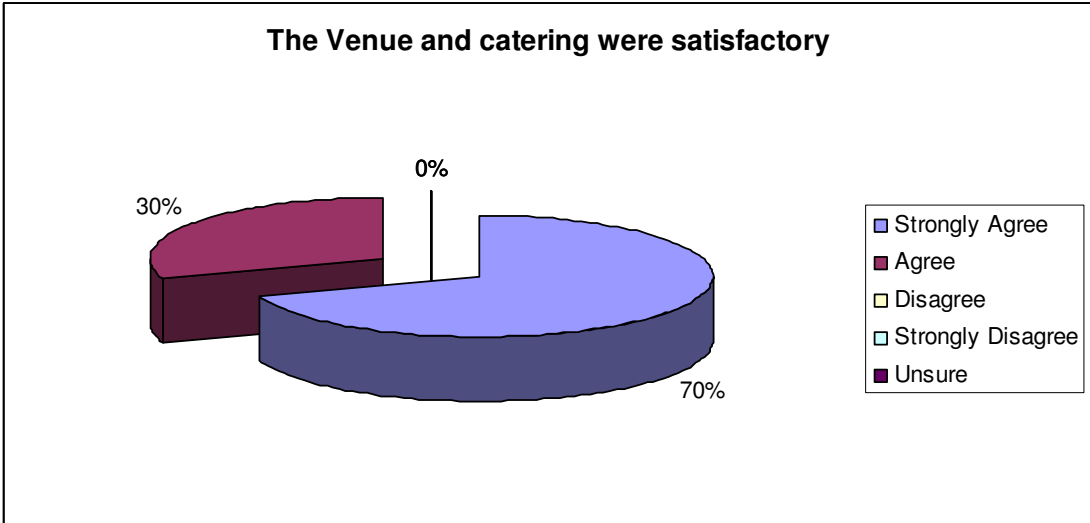
100% of delegates agreed that the event was relevant to their work



100% of delegates felt the content was presented at an appropriate level for them.

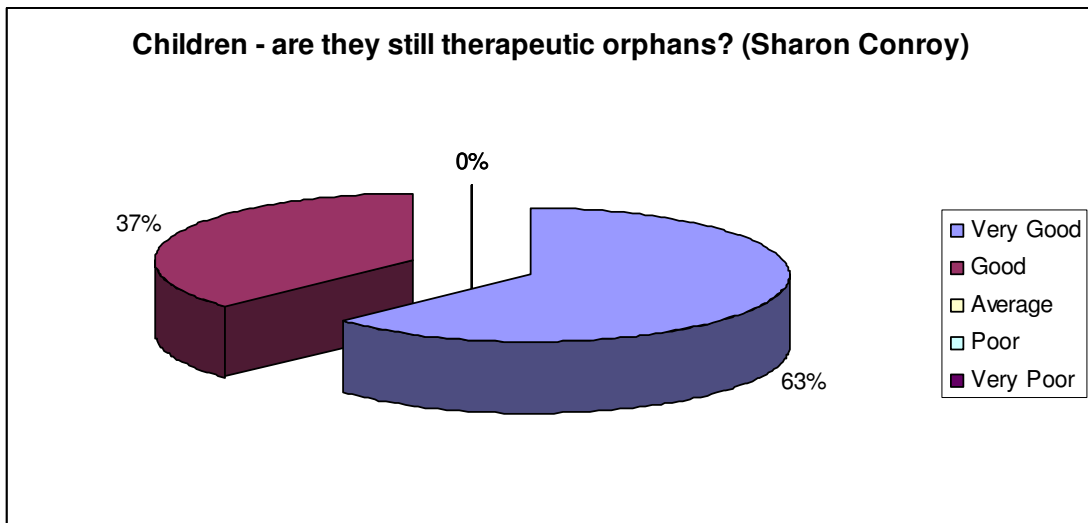
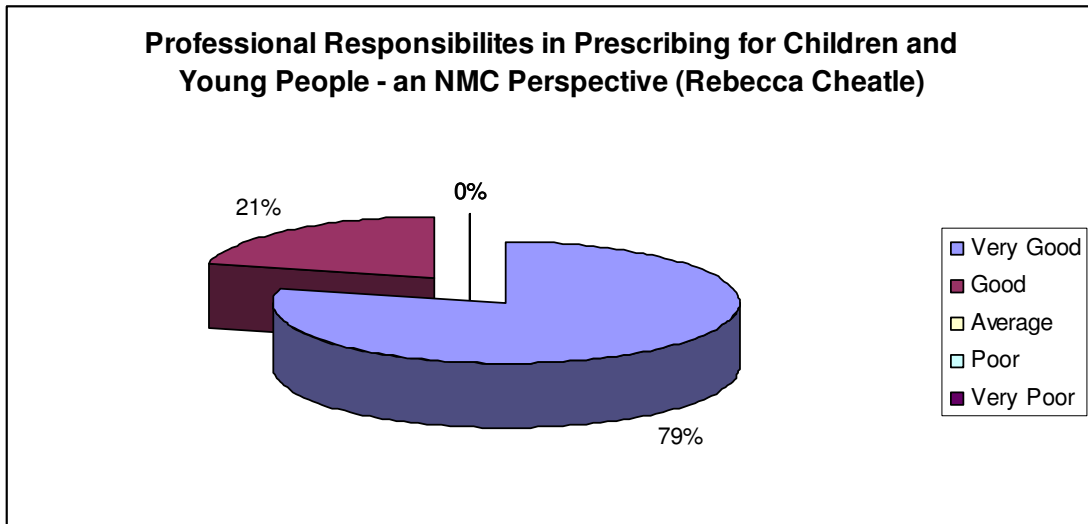

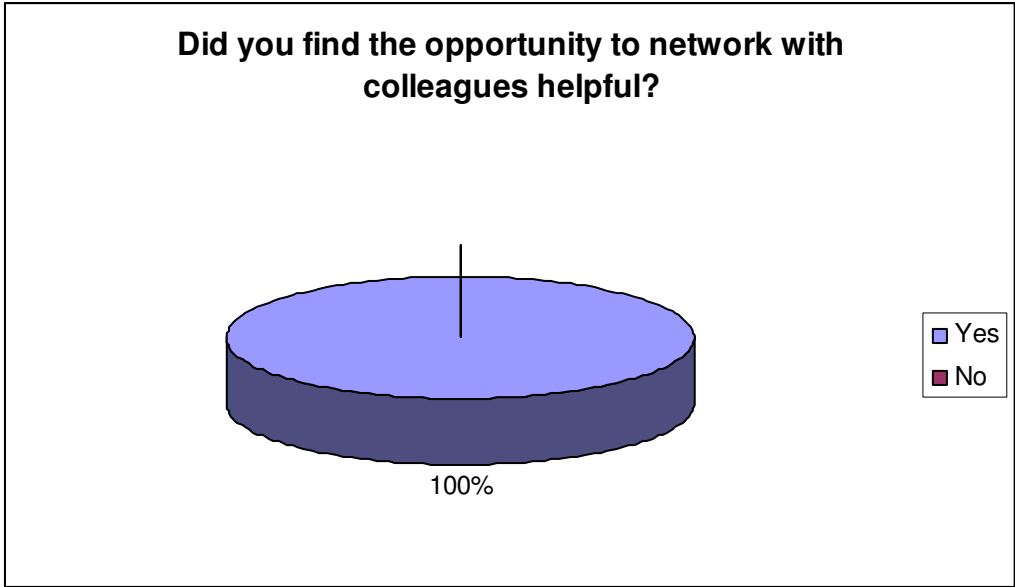
